Convenient access to your money.

Provides you with another payment option other than cheque or cash.

Use your compatible iPhone® or Android[™] phone to tap and pay with your eligible ANZ cards when you're out and about.⁷ Find out more at anz.com/mobilepayments Deposit funds via the ANZ App, ANZ Internet or Phone Banking, ANZ branches or selected ANZ ATMs. Check your balance at ATMs¹, via the ANZ App, ANZ Internet or Phone Banking².

Convenient access to your funds via ATMs³, online, over the counter, over the phone and overseas at over 29 million locations worldwide. To access your entire available account balance, simply select 'Visa Debit' or press the Credit 'CR' button when using your card through an EFTPOS terminal⁴ or at any ATM.

Deposit funds into your ANZ account via a Visa Direct enabled Original Credit Transaction (where available). Transfer funds to an account you hold with a Visa Direct enabled merchant or other person via an Account Funding Transaction (where available).

Better control of your business expenses.

Access money directly from your ANZ Business Transaction Account, anywhere Visa is accepted. Simplify your banking by separating your business and personal expenses, with an ANZ Business Visa Debit card for business purposes and an ANZ Access Visa Debit card for personal use, allowing you to spend more time focussing on your business.

View all outstanding authorisations, i.e. outgoing and incoming funds that are being held by a merchant prior to being fully processed, via ANZ Internet Banking, ANZ Phone Banking and ANZ Mobile Banking, to assist you to better manage your cash flow.

Temporarily block your eligible card if you misplace it or report your card as lost or stolen – all from the app. Choose the account, tap **Manage**, then **Manage Card** and follow the prompts.

Added security and peace of mind.

You have the added security of ANZ Falcon™ monitoring your account for suspicious transactions.

Visa Zero Liability⁵ policy provides peace of mind, simply select 'Visa Debit' or press the Credit `CR' button when making EFTPOS⁴ and ATM transactions and shop with confidence knowing you won't be liable for unauthorised purchases made on your card⁵.

ANZ Fraud Money Back Guarantee protects you from liability for unauthorised or fraudulent purchases on your card⁵.

A daily cash withdrawal limit of \$1,000 protects you against fraud or theft⁶.

A security microchip is embedded in the card making it more difficult to fraudulently copy your Visa Debit card details.

Visa Secure and eftpos Secure are free services that give you extra protection against unauthorised use of your card at participating online merchants. Then you just have to follow the instructions!

START USING YOUR NEW CARD NOW

GET STARTED IN 5 SIMPLE STEPS:

- 1. Sign the back of your card.
- To activate your card log in to the ANZ App, tap More on the Accounts screen, then Activate Card and follow the prompts to set your PIN, or call 1800 652 033.
- 3. Deposit funds into your ANZ Business Transaction Account.
- 4. Enjoy convenient access to your funds when purchasing in person, simply select 'Visa Debit' or press Credit 'CR' at the EFTPOS terminal and sign to activate the Visa Zero Liability⁵ policy and protect yourself from unauthorised transactions made on your card⁵.
- If you choose to use the PIN received in the mail, memorise the PIN and destroy the letter. You can now enjoy full access to your money using your PIN, including via ATMs.

If you wish to select a new PIN, simply log in to the ANZ App and select the card, tap **Manage** then **Manage card** and follow the prompts or you can visit any ANZ ATM in Australia and go to the PIN change screen.

Important.

- An ANZ Business Visa Debit card is not a credit card. You must ensure you have sufficient funds in your ANZ Business Transaction Account before use.
- There can be a short delay with some purchases for Visa transactions before they show in your account.
- Check your balance regularly and keep in mind any transactions that may still be outstanding.



Remember to select 'Visa Debit' or press Credit 'CR' to activate Visa Zero Liability⁵ and protect yourself from unauthorised transactions made on your card.

MAXIMISE THE SECURITY ON YOUR CARD

FOLLOW THESE STEPS TO KEEP YOUR TRANSACTIONS SECURE

1. Select 'Visa Debit' or press 'Credit' to activate Visa Zero Liability⁵ protection.

Visa Zero Liability⁵ provides peace of mind knowing that you will not be liable for unauthorised or fraudulent purchases made on your ANZ Business Visa Debit card, simply select 'Visa Debit' or press the Credit 'CR' button when making EFTPOS and ATM transactions to activate.

2. Authenticate your identity online.

Visa Secure and eftpos Secure are free services offered by Visa and eftpos respectively that will automatically send a One Time Passcode via SMS to your mobile number in order to authenticate the purchaser and protect your card against unauthorised usage at participating online merchants.

3. Report theft or misuse of your card promptly.

Report a lost or stolen card or any suspicious transactions, as soon as possible, within the ANZ App. Choose your account, tap Manage, then Manage Card or by calling 1800 033 844, 24 hours a day, 7 days a week. If overseas call reverse charge +61 3 9683 7043.

Protection against fraudulent activity.

Your ANZ Business Visa Debit card offers you additional security features, including ANZ Falcon[™] fraud protection, alerting us to ask you for confirmation of unusual or suspicious transactions through ATM, EFTPOS, online, over the phone and overseas transactions. And the ANZ Fraud Money Back Guarantee protecting you from liability for unauthorised or fraudulent purchases made on your card, provided you:

- have not caused or contributed to the loss; and
- have notified ANZ of any suspected misuse of your card within a reasonable time of any suspected fraud or misuse of your card.

RECURRING PAYMENTS

To make recurring payments using your ANZ Business Visa Debit card, simply provide your 16 digit card number, card expiry date and confirm the card is a Visa. Some organisations may require the Card Validation Code located on the back of your card.
