ANZ JOB ADS: MIXED BAG

KEY POINTS

- On a seasonally adjusted basis, ANZ Australian Job Advertisements bounced 1.5% in July, nearly reversing the 1.7% fall recorded last month. On an annual basis, growth ticked up to 7.3% in July (vs 6.9% in June).
- In trend terms, job ads eased 0.2% m/m in July, the first monthly fall in nearly four years. There has been a clear slowdown in m/m trend growth since February this year.

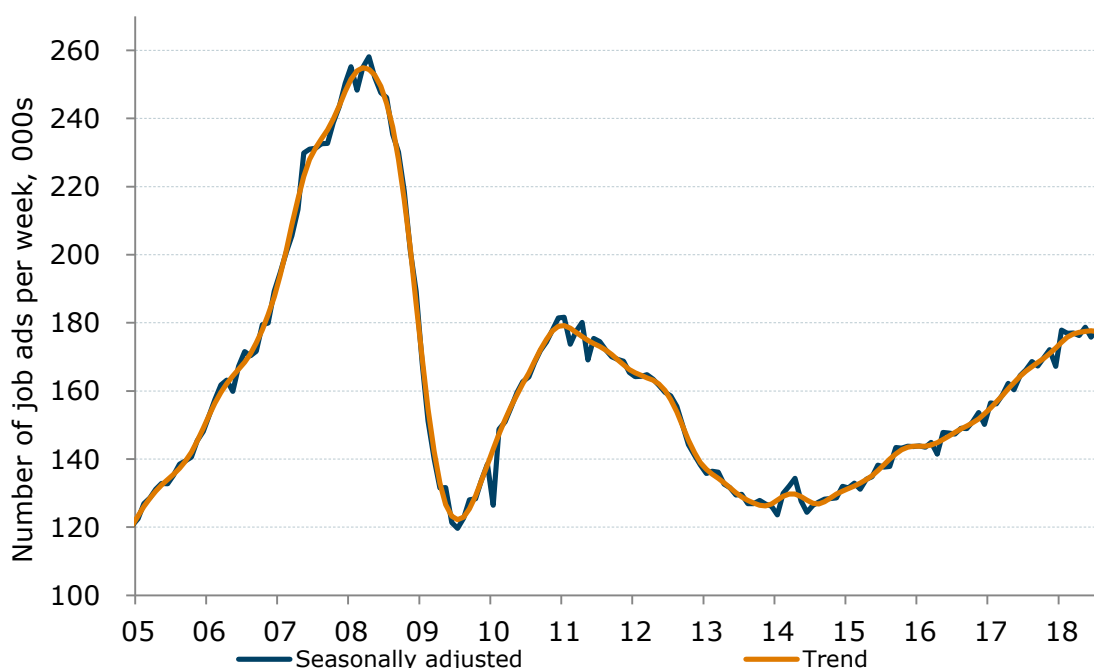
ANZ'S HEAD OF AUSTRALIAN ECONOMICS, DAVID PLANK, COMMENTED:

"Encouragingly the weakness in ANZ Job Ads in June did not continue into July. But reflecting the plateau in the level of job ads since the start of the year the monthly trend has softened considerably. In trend terms average monthly growth slowed from 0.8% in Q1 to 0.2% in Q2. Growth in July was -0.2%, the first fall since September 2014.

That said, other labour market indicators offer a contrasting picture. Business conditions, while down from record levels, remain well above long term averages. Capacity utilization and profitability also remain at high levels. As such we expect employment growth to continue at a pace consistent with a gradual decrease in the unemployment rate.

We will be closely watching the Job ads, however, as further weakness in the series may challenge our view. This in turn would have implications for wage growth, consumption and the return of inflation to the target band."

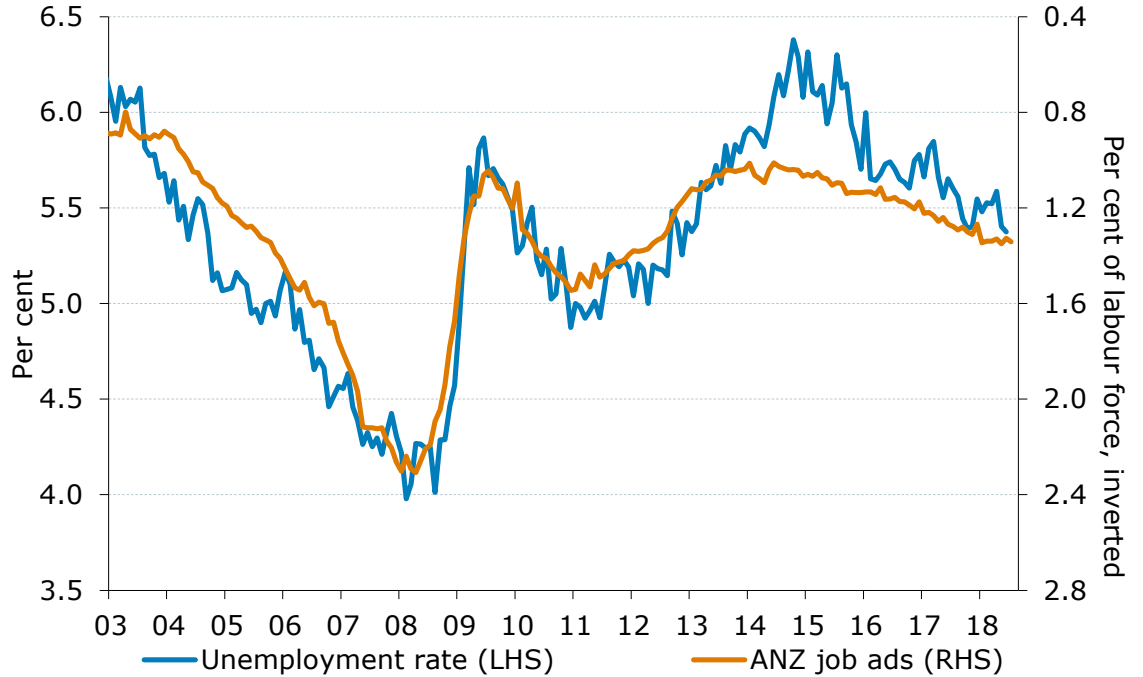

(c) Annual changes are on a year-average basis.

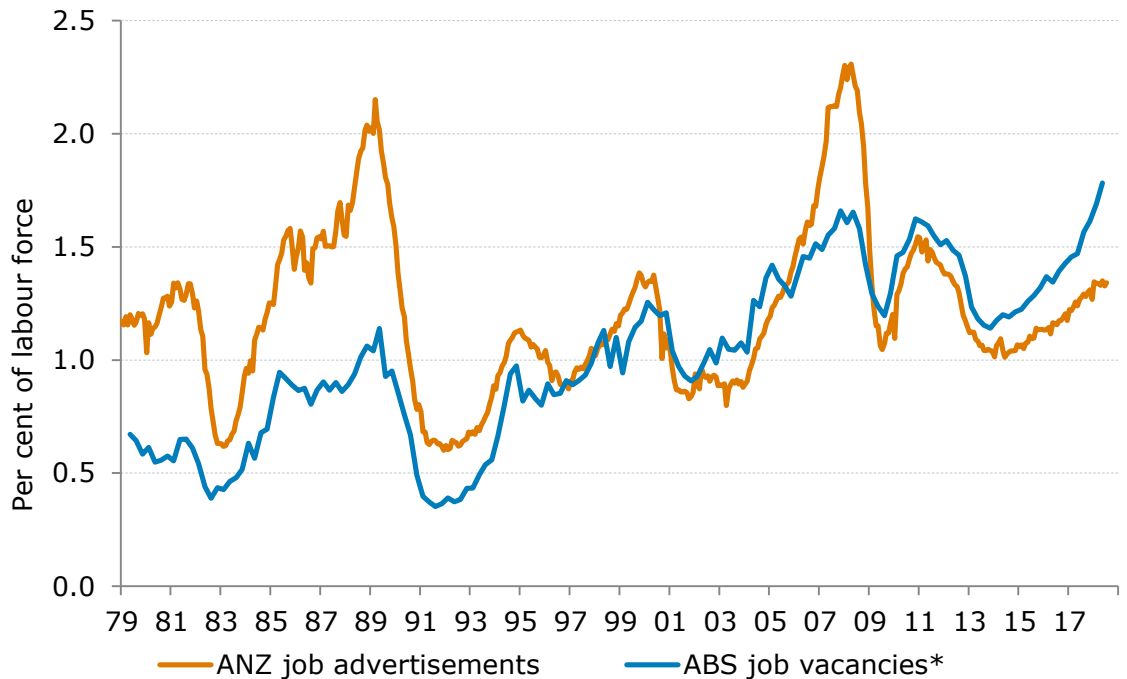

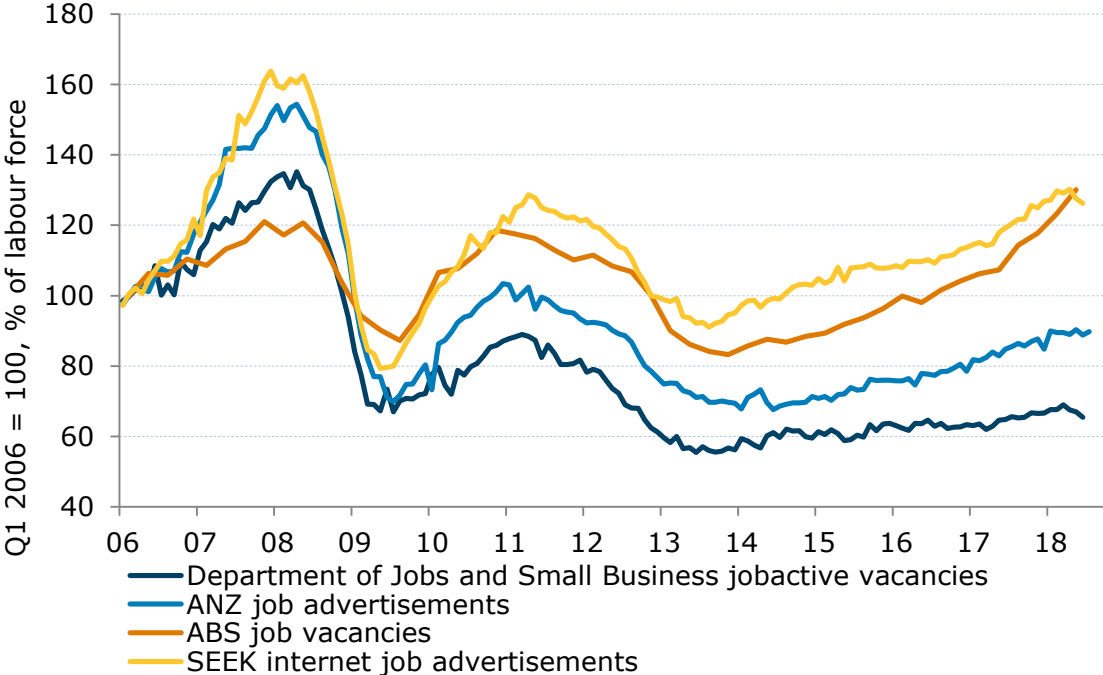
Figure 3. ANZ Job Ads and ABS Job Vacancies

TECHNICAL APPENDIX

The ANZ Job Advertisements series uses a concurrent seasonal adjustment methodology to derive the seasonal adjustment factors. This means that data from the current month are used in estimating seasonal factors for the current and previous months. Concurrent seasonal adjustment replaced the forward factor methodology from the June 2010 reference month.

The concurrent adjustment methodology uses the most recent data every month, whereas the forward factor approach used it only once a year. Under concurrent adjustment, the seasonal factors will also be more responsive to underlying dynamic changes than forward factors.

Concurrent adjustment can result in revisions to the seasonal factors each month to estimates for earlier periods. However, in most instances, the only noticeable revisions will be to the seasonal adjustment factors for the current month, the previous month and the same month a year ago.

The concurrent seasonal adjustment brings the ANZ Job Advertisements series in line with the methodology used by the ABS for its monthly employment data.

NOTE FOR EDITORS

For some of the newspapers surveyed, the ANZ Job Advertisements series counts the number of advertisement 'bookings'. Each booking may contain multiple advertisements. In addition, the series counts classified advertisements only, and does not include display advertisements. For these reasons, it would be incorrect to draw any inference or correlation from the ANZ Job Advertisements series regarding advertising volumes or revenues from employment advertising in the newspapers surveyed.
