ANZ JOB ADS: LOSS OF MOMENTUM CONTINUES

KEY POINTS

- In seasonally adjusted terms, ANZ Australian Job Advertisements eased slightly in April (-0.2% m/m), the third consecutive monthly decline (March -0.1% m/m, February -0.4% m/m). In y/y terms growth slowed to 8.6% in April, down from 11.5% in the previous month.
- In trend terms, job ads were up 0.4% m/m in April, following a 0.7% rise in March. The number of job ads currently sits 10.5% higher than a year ago.

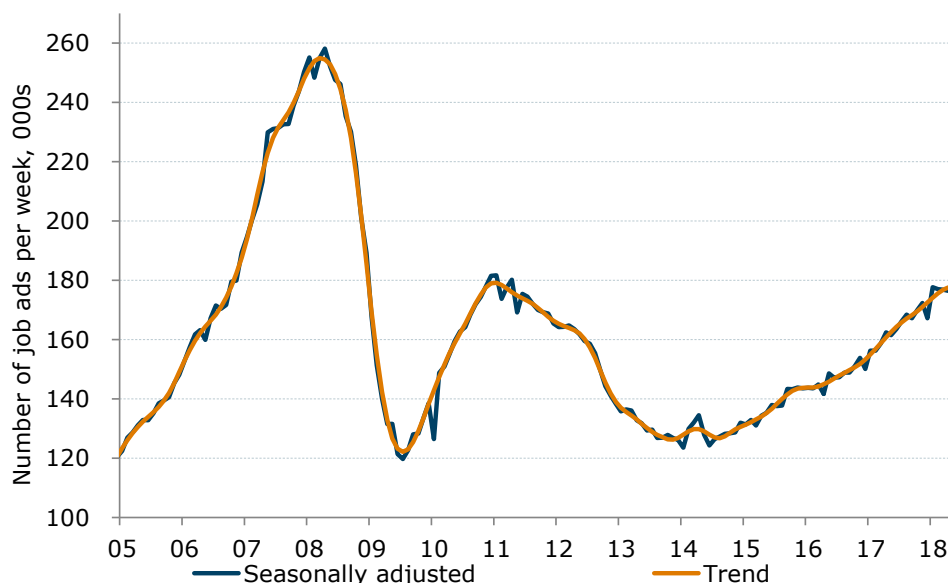
ANZ’S HEAD OF AUSTRALIAN ECONOMICS, DAVID PLANK, COMMENTED:

“After a sharp rise in January, ANZ Job Ads have eased slightly for the last three months. They are now 8.6% higher than a year ago, the slowest annual gain since May 2017.

Alongside the loss of momentum in job ads employment growth has also slowed. In part we think this slowdown in employment reflects payback after excessive strength.

While the growth in job ads has paused, the level of job ads is high and is consistent with ongoing employment growth. As well, business conditions and profitability remain well above their long term average. Levels of capacity utilisation also remain high. As a consequence we remain optimistic about the outlook for employment growth, even if we get some further adjustment after last year’s strength. For 2018 as a whole we expect jobs growth to be at a pace consistent with a gradual decrease in the unemployment rate.”

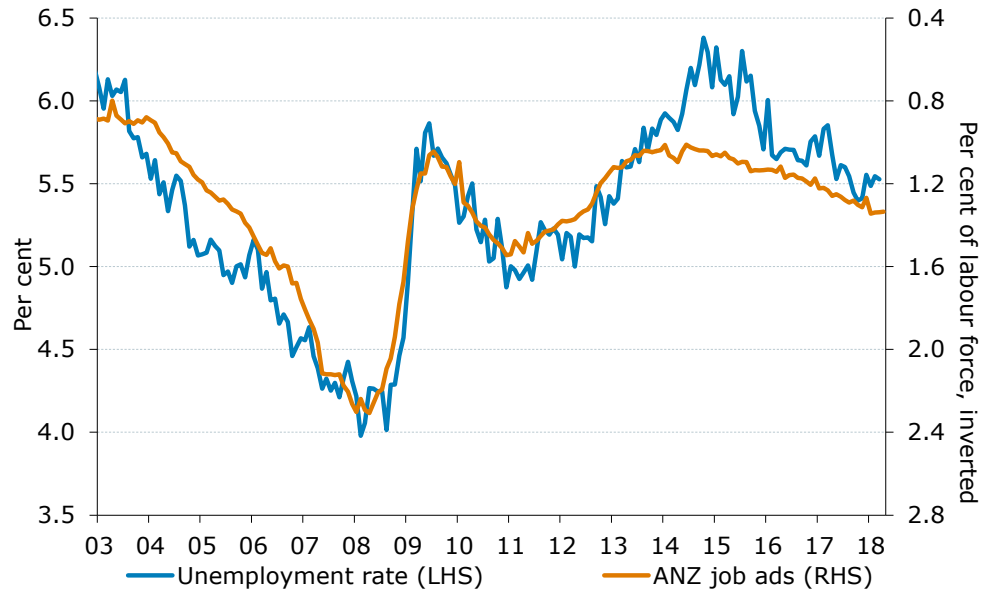

(c) Annual changes are on a year-average basis.

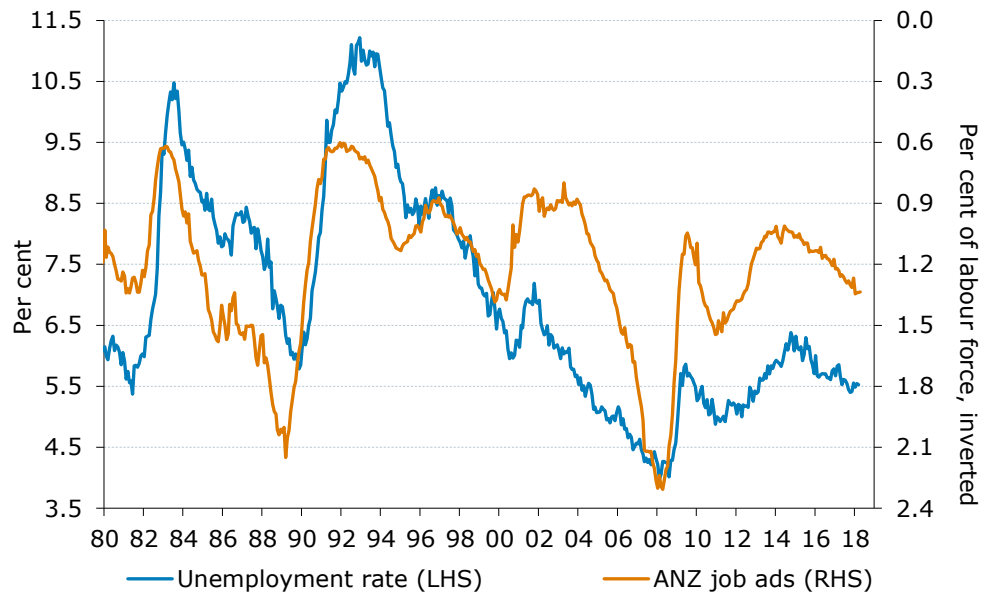

Figure 2. Unemployment rate and ANZ Job Ads since 2003



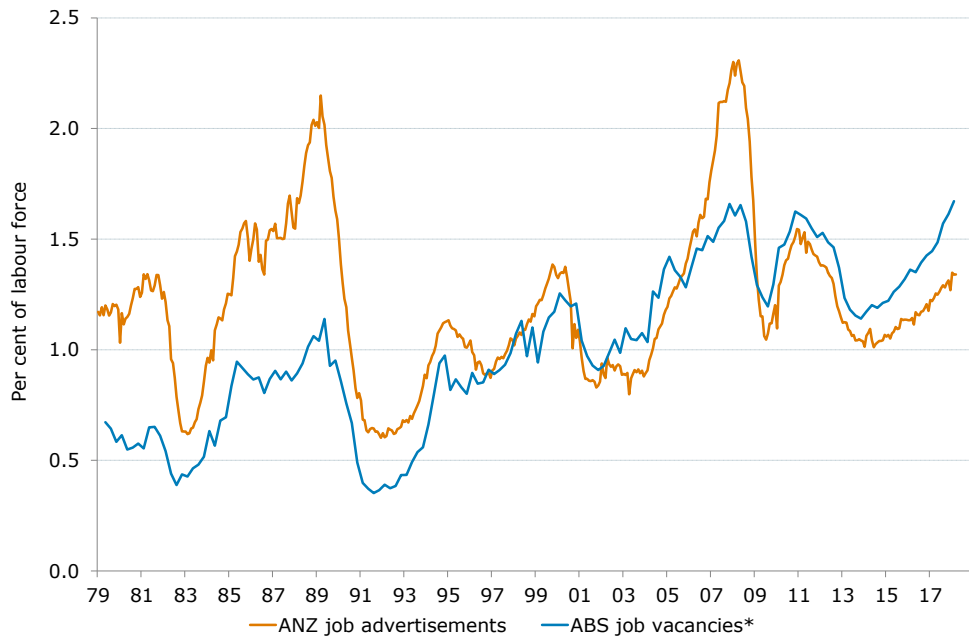

Figure 3. Unemployment rate and ANZ Job Ads since 1980



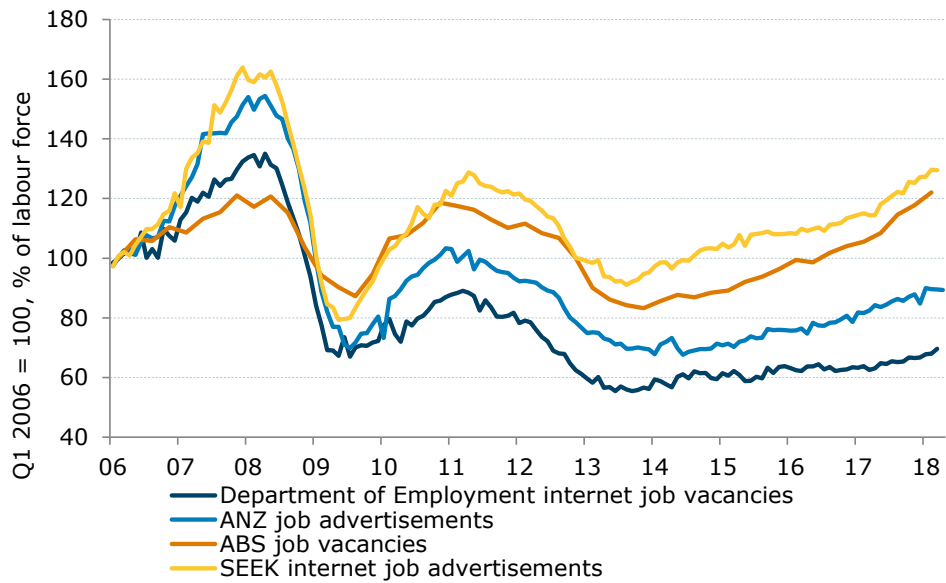

TECHNICAL APPENDIX

The ANZ Job Advertisements series uses a concurrent seasonal adjustment methodology to derive the seasonal adjustment factors. This means that data from the current month are used in estimating seasonal factors for the current and previous months. Concurrent seasonal adjustment replaced the forward factor methodology from the June 2010 reference month.

The concurrent adjustment methodology uses the most recent data every month, whereas the forward factor approach used it only once a year. Under concurrent adjustment, the seasonal factors will also be more responsive to underlying dynamic changes than forward factors.

Concurrent adjustment can result in revisions to the seasonal factors each month to estimates for earlier periods. However, in most instances, the only noticeable revisions will be to the seasonal adjustment factors for the current month, the previous month and the same month a year ago.

The concurrent seasonal adjustment brings the ANZ Job Advertisements series in line with the methodology used by the ABS for its monthly employment data.

For some of the newspapers surveyed, the ANZ Job Advertisements series counts the number of advertisement 'bookings'. Each booking may contain multiple advertisements. In addition, the series counts classified advertisements only, and does not include display advertisements. For these reasons, it would be incorrect to draw any inference or correlation from the ANZ Job Advertisements series regarding advertising volumes or revenues from employment advertising in the newspapers surveyed.
